A motion was made by Bucci, seconded by Allen to have the needed repairs at the Sewage Plant taken care of for safety factors. All were in favor, motion carried.

Bridge Repairs

The curbs on the bridge over the run are smashed down and need repaired. Pricing will be obtained for the next meeting. The Solicitor would like the borough to install cones around the area in the interim for safety.

Electric Poles Replacement

Verizon has a pole on Park Drive that is leaning. Kelly Jr. will contact them about replacing it and also the one on the corner of Orchard and Main Street.

Transfer of Funds
