Gail Blakeley – 310 Main Street

Gail has continued problems with her yard after the Waterline Project was completed. Kelly Sr. spoke with the borough's engineer regarding the issues and sent pictures. The engineer will be sending a two-week notice to the contractor to fix the issues.

She stated that the area where the trenches are dug is very rough and there are three deep holes. Her gas line was broken during construction, and she was without heat for one night. She also had to remove stones herself that were pushed under her bushes instead of being removed. The grass needs to be reseeded as well.

Karen Goebel – Friend of the Park

Karen thanked the borough for everything that has been done at the park. She is requesting some topsoil for around two trees for planting. One at the entrance to the park and the other by the playground and possibly some new mulch for the playground area.

John LaCarte – Stonecrest Development

John stated that they have all the permits required to move forward and that DEP has accepted all the plans. The urgency now is the state funding they received. He is open to reimburse costs until revenue will support the sewer system and can prepay some of the tap-in fees.
